Semester payments are due September 1 and January 1; monthly payments are due the first of each month beginning September 1.

- 2. There is a charge of 1.5% interest per month (18% per annum) on any amount due for any tuition other charges of **THE NEW SCHOOL**, not paid by the tenth of the month. There is a \$30.00 charge for a check returned by the bank for any reason.
- 3. The obligation to pay the full amount of this contract is unconditional and is, accordingly, unaffected by any circumstance or event including, without limitation, the withdrawal of our child from the school for any reason or our decision to forgo having our child attend the school, unless:
 - A. We move from the Greater Cincinnati Area and provide the school with 30 days advance written notice of the withdrawal, or
 - B. It is the sole judgment of the Director of **THE NEW SCHOOL**, based on medical information submitted to him or her, that one of us or our child has become permanently incapacitated,
 - C. In the sole judgment of the Director of **THE NEW SCHOOL**, our child should no longer attend the School.
- 4. That the tuition described above is for the specific hours indicated. Additional charges will be made for additional hours used and are due and payable by the tenth of the month following the month in which they are billed.

We (I) have read the enclosed material and acknowledge the additional expectations beyond tuition for participation at **The New School**, and jointly and severally agree to pay all tuition as selected above in Section 1 and all charges as provided in Section 4. This is a legally binding contract.
